# **TOURISMTIGER SPA – PRIVACY POLICY**

This privacy policy sets out how TourismTiger SPA (hence by referred to as "TourismTiger", or "we", or "us") uses and protects any information that you give us when you use this website.

TourismTiger is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

TourismTiger may change this policy from time to time by updating this page. You should check this page intermittently to ensure that you are happy with any changes.

### 1. Personal data

#### a. Purpose and type of data collected

We will collect your personal data for the purposes of providing you with marketing, web-design, sales offers or industry advice.

The types of personal information or personal data we may collect about you include:

- Your name

Any other personal information requested by us and/or provided by you or a third party.

We may collect these types of personal information directly from you or from third parties.

#### b. Collection and use of personal information

We require this information to understand your needs and provide you with a better service. In particular, your information will be used for the following reasons:



- · Internal record keeping and administrative purposes
- To enable you to access and use our Site, associated applications and associated social media platforms
- · We may use the information to improve our products and services

In addition, in the event of a merger, consolidation or reorganization involving TourismTiger, acquisition of TourismTiger by another company, or any other similar transaction, your personal information will, in most instances, be transferred to the control of the third party that is part of that transaction.

Where we disclose your personal information to third parties, including data processors, we will request that the third party handles your personal information in accordance with this Privacy Policy. The third party will only process your personal information in accordance with written instructions from us and we require that the third party either complies with the privacy shield principles set out in the GDPR or another mechanism set out by applicable EU & Swiss data protection laws for the transfer and processing of personal information. When we refer to 'processing' in this clause and this Privacy Policy in general, we mean any operation or set of operations which is performed on personal information, whether or not by automated means, such as collecting, recording, organising, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available personal information.

# 2. Security

## 3. Cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive.
